#### **Decides**

# **Article 1:**

Have been allowed to use national budget allocated in the budget cadre of the Ministry of Health to provide allowance support to midwife which has provided delivery service at national hospital, national centre, referral hospital, health centre and health post to maximize reduce the maternal and infant mortality rate.

### **Article 2:**

60,000 Riels (Sixty Thousand Riels) is provided to a midwife for delivery a baby at health center of health post.

40,000 Riels (Forty Thousand Riels) is provided to a midwife for delivery a baby at national hospital, national center and referral hospital.

#### **Article 3:**

Other conditions in providing allowance support to midwife whose provide delivery service at public services are set thereof:

- For national hospital, national center and referral hospital shall consist of relevant documents or letters validated by the signature of respective hierarchy and approved by chief of the unit
- For health center and health post shall consist of relevant documents or letters validated by the signature of respective hierarchy with the approval of the chief of the unit and certified by the commune-sangkath council
- For a death infant after delivered or during the nursing period at the delivered places shall not be accounted to grant the allowance support.

#### Article 4:

Report sample and technical documents as well as other relevant letters shall be prepared by the department of hospital of the Ministry of Health.

### **Article 5:**

The payment of above mentioned allowance stated in article 2 shall be done once in a quarter after all relevant reports, documents and letters have been verified its appropriateness to the financial procedures.

#### Article 6:

Directorate General of Administration and Finance, Directorate General for Health, all provincial-municipal health department, national hospital, national center, referral hospital, health center and health post, concerned parties under the management of the Ministry of Health and the Ministry of Economics and Finances shall be responsible in effectively implement this sub-decree from date of the signature.
