Hereby Decides

Article 1: Establish Evaluation Committee on Level of Certificate and Letter of Confirmation with below components:

Article 2: Chairman, deputy chairman and all members of this committee shall bear at least certificate of Master Degree.

Article 3: This committee has the following duties:

- Evaluate level of both domestic and foreign certificate and letter of confirmation based on the requests for evaluation from personnel or any entities in the country.
- Establish evaluation criteria for both domestic and foreign certificate and letter of confirmation

Article 4: Deputy-Chairman, committee members have to attend the meeting call upon by the chairman. Whereof, the chairman is assigned to another mission abroad or takes leave of any reason, permanent deputy-chairman is supposed to perform the duty on behalf. Within the evaluation process of the certificate of letter of confirmation, the personnel or subject entities can assign a representative or the subject personnel to clarify and provide necessary information for the committee.

Article 5: The committee shall establish a permanent secretariat which is stationed at the council of minister and has the rights to use seal of the Accreditations Committee of Cambodia for facilitation process. Components, roles and duties of this permanent secretariat shall be defined by the committee.

Article 6: Decision 34 SSR dated April 09, 1999 of the Royal Government and other regulations that are contrary to the contents and regulations of this decision shall be deemed abrogated.

Article 7: The Minister in charge of Council of Ministers, Minister of the Ministry of Education Youth & Sports, Minister of the Ministry of Economics and Finance, Minister of the Ministry of National Defense, Minister of the Ministry of Health, Minister of the Ministry of Agriculture Forestry and Fisheries, Minister of the Ministry of Labor and Vocational Training, Minister of the Ministry of Religious Affairs, Minister of the Ministry of Culture and Fine Arts, Secretary of State of the State Secretariat of public functions, Royal Academic of Cambodia, Ministers, Secretary of State of relevant ministries, Accreditations Committee of Cambodia and components as stated in Article 1 of this decision shall effectively implement this decision from the date of signature.
