Hereby Decides:

Article 1:

Determination of the key responsibilities and the delegation of responsibilities to Ministers, Secretary and Under- Secretary of State in order to ensure implementation and the leading of general affairs of the Ministry of Health as below:

- **Excellency Mam Bunheng:** the Minister is responsible for overall and directly leading the tasks as below:

- Policy, Planning and Promotion
- Respond to the disaster
- Control HIV/AIDS, Malaria, Tuberculosis
- National/International cooperation and sign on the agreement.

1. His Excellency Heng Taykry: Assists his Excellency Minister on the tasks:

- Public Hospital Services
- Private Hospital Services
- Emergency
- Non-communicable disease

2. His Excellency Ing Phyrun: Assists his Excellency Minister on the tasks:

- Environmental health
- Health promotion
- Oral and dental health
- Preparation of drafts of law

3. His Excellency Eng Huot: Assists his Excellency Minister on the tasks:

- Lead the Health Sector Supporting Program (HSSP) – Merit-Based Performance Incentive (MBPI) and Special Operation Agency (SOA).
- Communicable Disease Control - Quarantine
