- Seen the Law on Co-Statute of Civil Government Officials of the Kingdom of Cambodia, dated on 21 October 1994, and
- For the necessity of Ministry of Health.

Decides

**Article 1**

The content of Article 24 of Ministry of Health's *Prakas* No. 021 ABS/MP, dated on 4 September 2003, shall be modified as the following:

Article 24 (New)

- The consulting cabinet, the dental cabinet, the physiotherapy cabinet, the nursing cabinet, and the aesthetic surgery cabinet provided with a legitimate logo registered with provincial/municipal Health Department shall be licensed every three years.
- The medical laboratory, the obstetric clinic, the clinic, the dental clinic, the polyclinic provided with a legitimate logo registered with Ministry of Health shall be licensed every four years in case the doctor or the pharmacist or the dentist who represent the establishment as the manager has retired or abandoned the state service. On the other hand as for the officials who are serving the state service and has asked for a suspension of the service without pay in order to represent the establishment as the manager, the Ministry of Health will provide the license that is valid as long as the period of the service suspension without pay takes.

When the license becomes expired, the manager of all private services shall make a request for a renewal of that license or change the person who represents the establishment as the manager.

Article 2

The Health Technical Department General, the Directorate of Ministry of Health, the Hospital Department, and provincial/municipal Health Department have the duty to implement this *Prakas* effectively.

This *Prakas* shall be in effect as of the date the signature is affixed.
